3. Retired Assam Accounts and Assam Audit Services may also attend the Walk-In Interview. In such cases, the designation will be "Accounts Advisor".

Duties and Responsibilities:

The Financial Advisor/Accounts Advisor will be responsible for managing all financial matters including:

- Preparation of budget, procurement, vetting of sanctions, and compliance with audit observations and related administrative matters (service, pension, leave, etc.) of Government budgetary allocations and funds of the Society of the Medical College & Hospital.
- Monitoring of projects and schemes implemented with GoA/Gol funding.
- Collection and management of any fees collected by the College & Hospital.

Remuneration:

The remuneration for the contractual Financial Advisor/ Accounts Advisor will be fixed as per the general principle of the "last pay minus pension" formula, in accordance with Circular No. DME/Estt/643395/5 dated 09.07.2025 issued by the Director of Medical Education, Assam. Payment will be made monthly from the Hospital Management Society of Lakhimpur Medical College & Hospital, Lakhimpur.
